Application areas are centered on customer-funded projects as per the approved Centre's POW, and may extend to the operation of shared infrastructures used to deliver Centre output. Type of Contract: CMRE intends to award multiple Basic Ordering Agreements (BOAs)

against which issue separate Firm Fixed Price (FFP), level of effort - Indefinite Delivery Indefinite Quantity (IDIQ) task orders based on pre-

agreed hourly rates.

Award Method: Multiple awards based on Lowest Priced Technically Acceptable

(LPTA) bids.

Funding: Est. annual cost: Euro 200K-700K

Eligibility: Solicitation is open to all governmental and/or commercial entities that

2025). Specific performance periods will be stated in the task orders.
